# **Role Description**

Assist with cased hole well programmes, well campaign equipment preparation, on-site engineering support during well operations as well as integrity management of all operated cased wells.

## **Roles and Responsibilities**

(Include but are not limited to the following):

- Field Production assist with well surveillance & production monitoring and execute activities to improve well performance. Responsible for daily production reviews, gas nominations, monthly production reporting and six-monthly well integrity reviews.
- Cased Hole Well-work Planning Assist with preparation (with guidance from more senior team members) technical programs for well completions, workover, stimulation, abandonment, etc. Assist with preparation of well-work management documents including WOMP.
- Perform fundamental calculations that guide well equipment specifications and operations planning that
  include but are not limited to; pore pressure and fracture gradients, gas gradients and maximum surface
  pressures, axial, torsional and temperature checks against equipment specifications, fluid volumes and
  hydrostatics in pumping operations, required test pressures and sequences etc.
- Working closely with industry service providers, ensuring clear communication and understanding of their expected roles and responsibilities, and identifying the gaps between service providers where the operator must provide support.
- Provide team input to optimizing operational sequences, methods and equipment to meet a well's program objectives. Perform cost / benefit reviews as relating to well operations as required.

- Participate in operational, integrity, safety and environmental risk assessments as required for operational planning.
- Liaise with other Mitsui divisions such as HS&E, procurement and contracts as relevant to operations being undertaken.

- Undertake technical investigations / studies with support and guidance from senior team members as required.
- Compile close out reports for well operations.
